Storey do hereby expressly consent to the jurisdiction and venue of the State Courts of Floyd County, Georgia. In the event this account is placed in the hands of an attorney for collection, the undersigned agrees and promises to pay an attorney's fee of not less than 15% of the balance due and owing.
